#### 1. Background

Asansol Girls' College is 'B++' accredited by NAAC in 3<sup>rd</sup> Cycle and prestigious college in the industrial belt of Asansol, Paschim Bardhaman district, West Bengal, India. It offers undergraduate courses in arts, commerce and sciences. It came into existence in 1950 mainly as a result of untiring effort of Dr. Lalit Mohan Sen, the then CSO, mines board of health and his worthy consort Smt. Kamala Sen. Initially, the College was affiliated to the University of Calcutta. After Burdwan University started it became affiliated with that university and now, the college has been affiliated to Kazi Nazrul University. During the difficult years of its adolescence, the college was fortunate to have Dr. Anjali Roy as its principal. This is a premier college for highest academic standards, different educational programs, grand faculty, and various co-curricular activities and modern infrastructures. The College provides hostel facility to the students from distant places. There are two hostels - Unit I (Anjali) and Unit - II (Nivedita). Today, it has become high spirited institution for learning

Trivenidevi Bhalotia College commenced its journey in 1957 as a UGC registered College [under 2(f) and (12b)], affiliated under the University of Calcutta. It became affiliated to the University of Burdwan in 1960. Presently the College has come under the aegis of Kazi Nazrul University on and from 24th June, 2015. The College is a co-educational institution which is run in two sections – Morning section and Day section.
